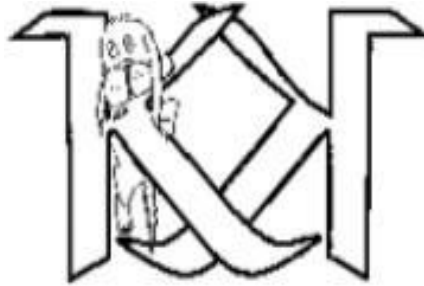

**About fun matches:**

The purpose of fun matches is to encourage good behaviors and enthusiasm while practicing your skills in a trial environment. Toys, treats, clickers, and targets are welcome in the ring. Dogs are allowed to run at a jump height lower than what they would run in a sanctioned trial. Each dog will have the opportunity to run both courses twice. The second run will begin once the first round has been completed. You are welcome to run a different level for your second run; for example, you may choose to run a starters level course the first time and an advanced level course the second time.

**General Information:**

This fun match will run by AAC rules and regulations.

Courses will be nested, so the A-frame will be set at 5' for everyone and there will be no broad, double, or spread jumps.

Obstacles that will be used are: Weave Poles, A-Frame, Dog Walk, Teeter (rubber-coated), Table, Flexible Tunnel, Collapsible Tunnel, Tire Jump, Single Bar, and Wing Jumps.

The event is being held at the Krazy Kanines' fenced outdoor field, 1660 Vimont Court. Directions are below.

There is plenty of room for crates, tents, and parking.

Spectators are welcome.

The event will run rain or shine.

**Schedule:**

Check-in at 8:30 am

Briefing and walkthrough at 9:00 am

First dog on the line at 9:15 am

**Directions:**

Our field is located at 1660 Vimont Court, one minute from the Trim Road exit of Highway 174. From Ottawa, exit Highway 174 at Trim Road, turning right onto Trim Road. Turn right onto Taylor Creek Drive, then left onto Vimont Court.
